Additional Valuable Healthcare Services

Gunnison Valley Hospital provides gastric sleeve surgery as a service to patients who would benefit from major weight loss and who can commit to living a new, healthier lifestyle. The surgery reduces the size of the patient's stomach, creating a smaller stomach or "sleeve," which restricts the amount of food that can be eaten at one time. Following a consultation, the procedure requires an educational course led by a registered nurse and a new pre-operative diet as preparation. Our skilled surgeons have performed more than 100 successful procedures this past year.

Improvements in Care

We've been engaged in a year-long process to become certified by the State of Utah as an official Trauma Center. A trauma patient is one who arrives at the hospital with life-threatening trauma in multiple areas of the body. The most common cause of such trauma is motor vehicle crashes. Trauma centers are trained to provide specialized medical services and resources to patients suffering from these injuries. The Utah State Department of Health indicates that patients who are treated at a trauma center have a 25 percent better chance of survival than those who are treated at a noncertified hospital.

We've also been working on procedures targeted at improving health care response times in the areas of stroke, heart attack and urgent/emergent C-sections. Additionally, we've increased the level of our Total Joint Replacement care to insure we are below the national standard for infections.

Prepared for the Worst

Gunnison Valley Hospital prioritizes emergency preparedness. Over the past five years, key staff have attended Federal Emergency Management Agency classes for Leadership Training in Incident Command and Infectious Disease. We maintain an emergency management committee that meets every quarter,



in addition to our regular quarterly meetings with the County Local Emergency Planning Committee and the Six County Health Care Coalition. Additionally, we have prepared and trained senior management and other key staff on decontamination, bloodless emergencies, earthquake scenarios and active shooters.

Recognition

Gunnison Valley Hospital accepted an award from Becker's Hospital Review for its 5-star overall hospital quality rating from the Centers for Medicare & Medicaid Services. We are proud of being recognized for our exceptionally low rates of readmission and mortality, and our exceptionally high standards of safety, patient experience, effectiveness of care, timeliness of care, and efficient use of medical imaging. Additionally, we earned recognition as one of the iVantage Health Analytics Top 100 Critical Access Hospitals, best health center of Sanpete County in the 2018 Daily Herald Readers' Choice Awards, and one of America's 100 Best Hospitals for Patient Experience in the 2019 Women's Choice Awards.



Fighting a Crisis

For over a year now, Gunnison Valley Hospital has tracked opioids given out in emergency room and outpatient settings. In an attempt to reduce overall opioid use, we discourage the use of opioids for people who present with headache, back and dental pain. We inform all of our surgical patients about safe opioid use and disposal of unused medications. Additionally, we regularly encourage students and young adults to watch *Chasing the Dragon*, a short documentary about the dangers of opioid addiction.

SERVICE AREA

Large Geographical Area

With our central location in Gunnison, Utah, we are able to provide health care services to a large area of Central Utah. Patients have traveled to the hospital from as far as Hanksville to the southeast, Ferron to the east, Scipio to the west, and Fairview to the north. Also, in an effort to provide quality health care closer to home, we work with health care providers in seven clinics located in Gunnison, Manti, Monroe and Salina. Additionally, our home health and hospice teams serve all of Sanpete, Sevier and Wayne Counties. During the most


Area Statistics



INVESTMENT

New Addition

Our largest investment this past fiscal year was the completion of our operating room project, which included a major remodel and the implementation of a new fetal monitoring system in our labor and delivery unit.



Partnerships

We continue to strengthen our partnership with the multi-specialty physician group Revere Health in providing primary care in Gunnison, Monroe and soon in Manti. Revere Health opened its doors more than 50 years ago and now offers healthcare at 100 locations in Utah, providing comprehensive and high-quality healthcare in 29 medical specialties and family medicine.

Sleep Studies

We have developed a new partnership with Sleep Medicine Associates, based in Reno, Nevada, to reopen our program for fully accredited polysomnography. Since February, we have performed over 30 studies to determine if patients have sleep apnea, periodic limb movement disorder, narcolepsy, REM sleep behavior disorder, unusual behaviors during sleep and unexplained chronic insomnia. Our goal in participating in the sleep studies is to better understand the sleep conditions in our



community and provide patients with recommended treatments.

Telemedicine

Telemedicine gives Gunnison Valley Hospital the ability to video conference with medical experts from all over the country for assistance in evaluating, diagnosing and treating patients. Telestroke is one of the most used telemedicine services at the hospital and it has quite literally saved lives. When a patient is



having a stroke, quick treatment is very important. Telestroke enables Gunnison Valley Hospital to connect with an on-call neurologist at the University of Utah to review the CT scan and quickly help determine the best course of treatment. We also use our telemedicine partnership with the University of Utah to provide burn care and behavioral health services.

Looking Forward

In the 2019-20 fiscal year, Gunnison Valley Hospital will recruit and hire a new family practice provider who specializes in obstetrics. We will also launch a brand new Gunnison Valley Hospital website designed to provide increased resources and information to best serve patients. The new website will be focused on educating and informing patients in an effort to promote health and wellness within our community. We are also working to fully staff a new clinic in Manti to expand our service area.







A Positive Impact

A positive impact that often gets overlooked for a healthcare provider is the importance of their contribution to the local economy as an employer. Gunnison Valley Hospital employed 191 full- and part-time people this past year. The economic impact of the wages paid by an employer to their employees is estimated to be between 1.5 and 2 times the dollars paid. In fiscal year 2019, Gunnison Valley Hospital paid \$7.16 million in salaries and wages.



Hospital Gives Back

Gunnison Valley Hospital has a long tradition of serving every person who requires healthcare services, regardless of ability to pay. Through our charity care program, we have been able to bridge the gap between ability to pay and cost of healthcare services for 84 patients this year. The cost of this program was \$213,000 in fiscal year 2019.

Chontae Thompson knew she needed to lose weight. After being prescribed two blood pressure medications and witnessing several severe family health issues, she knew something had to change. Diets weren't working. So, a month after learning about gastric sleeve surgery and discussing it with loved ones, she decided to undergo the procedure. The procedure was a success and she recovered quickly. Almost immediately, Chontae noticed a reduction in the pain in her feet caused by swelling and her husband noticed the lack of snoring at night. To date Chontae has lost 95 pounds. She is able to exercise regularly and no longer needs her blood pressure medication. Another positive side effect is her increased happiness. She said "I honestly never thought I was depressed, but I can see how happy I am now and I can say without a doubt I was depressed. Thanks to the gastric sleeve, I feel like I have my life back."
